WORK AUTHORIZATION

I hereby authorize **MARINE MAINTENANCE OF BAY CO, INC** (MMBC) to do the repair work @ \$95.00 per hour along with the necessary materials, for the length of one year or _____ from the date below. Marine Maintenance and its employees may operate the unit on any waterways or elsewhere for purpose of testing, inspection or delivery at owner's risk. An express mechanic's lien is acknowledged on labor and materials to secure the amount of repairs thereto. It is understood that Marine Maintenance will not be held responsible for loss or damages to the unit (or articles left in or with the unit) in case of fire, theft, accident, inclement weather conditions or any other cause beyond Marine Maintenance's control.

I also understand that no work will begin nor any schedule for work will be made until **MARINE MAINTENANCE OF BAY CO, INC** receives this authorization.

A major credit card number (Visa, MasterCard, or American Express) and the expiration date of such, will be required or a 50% deposit payable by check, cashier's check or money order, before work starts. Invoices will be paid with the credit card number you furnish or by check at completion of job. Payment for all work performed is the responsibility of the vessel owner. Original Warranty will be filed for Volvo Penta, MAN, Cummins, Onan, Kohler, Westerbeke, Northen-Lights, Glendinning or Mase Generators, however, any items or labor not paid by Warranty will be due and payable from the owner. Owner to file after-market Warranty/Insurance claims themselves. Payment is due from owner no later than ten (10) days from completion of work. We charge mileage and travel time on each job from our shop to your job and return trip.

REMEDIES UPON DEFAULT: Should you fail to make any payment as required by this Agreement MMBC shall be entitled to proceed with its available legal remedies against you without further notice, with the exclusive venue for any actions arising out of breach of this Agreement being in Bay County, Florida. Further, you shall reimburse MMBC for all reasonable attorney's fees and cost associated with collection of this account, plus interest on the unpaid balance in the amount of 18% per annum or the maximum amount allowable by law (whichever is greater), retroactive to ten (10) days after the debt first became due. Further in the event of your breach of this Agreement, you hereby waive any head of household exemption under Florida Statue 222.11(2) (b) and/or any other applicable Florida statue, and you KNOWINGLY, VOLUNTARILY, AND INTENTIONALLY WAIVE THE RIGHT TO A TRIAL BY JURY.
